

7. Brief narrative as to why the reduction was made:

The subject property was inspected on September 8, 2010. As a result of this inspection, physical obsolescence in excess of "typical" obsolescence for 1970's vintage apartments was discovered. Recognizing costs to cure the obsolescence resulted in a value reduction. The level of obsolescence is considered to be equal for both 2009 & 2010 tax years.

8. Both parties agree to be responsible for their own costs, expert and attorney fees, waiving any claim against each other for such, and agree that any hearing before the Board of Assessment Appeals not be scheduled or be vacated if already scheduled.
