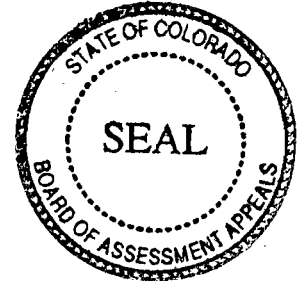

7. Brief narrative as to why the reduction was made:

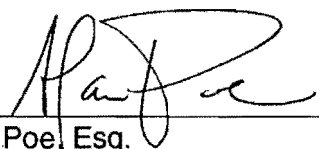
The value was adjusted after review of actual income and expense levels.

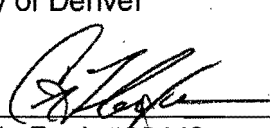
