4. The Board concurs with the Stipulation.


**ORDER:**



Petitioner, CAPONE FAMILY PARTNERSHIP, LLLP, and Respondent, BOARD OF EQUALIZATION OF THE CITY AND COUNTY OF DENVER, hereby enter into this Stipulation regarding the tax year 2010 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.
