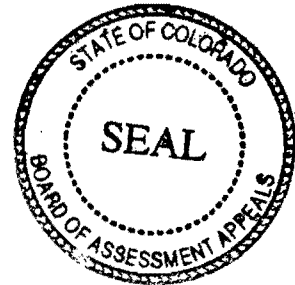




Respondent.

4. The parties agree that a facsimile, photocopy, or electronic copy of this stipulation shall be as effective as the original.


