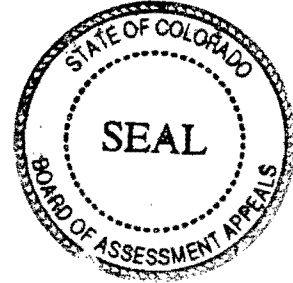


The recognition of functional and physical aspects resulted in a reduction.
