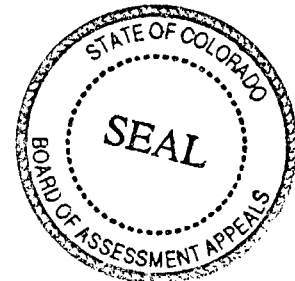

7. Brief narrative as to why the reduction was made:


Vacancy and actual income support a lower value.
