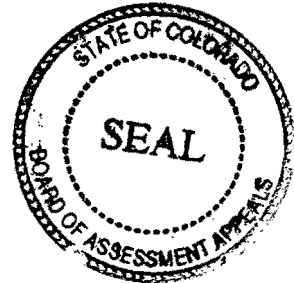

7. Brief narrative as to why the reduction was made:


The reduction was made so as to be in better conformity with actual and market income and sales data bearing on the subject property valuation.


