3. The County Assessor originally assigned the following actual value on the subject property for tax year 2010.

4. After appeal to the Board of Equalization of the City and County of Denver, the Board of Equalization of the City and County of Denver valued the subject property as follows:

5. After further review and negotiation, the Petitioner and Board of Equalization of the City and County of Denver agree to the following actual value for the subject property for tax year 2010.

6. The valuations, as established above, shall be binding only with respect to tax year 2010.

7. Brief narrative as to why the reduction was made:

The value was adjusted after a field review of the subject property verifying the condition and the functional obsolescence of the building addressed by the petitioner. Also, consideration was made to adjust the value based on the subject's base year appraisal.


