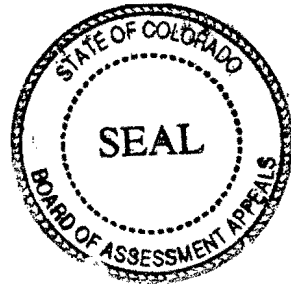

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2009.

4. After appeal to the Board of County Commissioners of the City and County of Denver, the Board of Equalization of the City and County of Denver valued the subject property as follows:

6. The valuations, as established above, shall be binding only with respect to tax year 2009.

8. Both parties agree to be responsible for their own costs, expert and attorney fees, waiving any claim against each other for such, and agree that any hearing before the Board of Assessment Appeals not be scheduled or be vacated if already scheduled.
