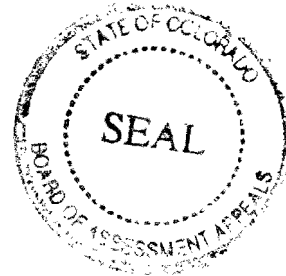

**STIPULATION (As to Tax Year 2010 Actual Value)**

Petitioner and Respondent hereby enter into this Stipulation regarding the tax year 2010 valuation of the subject property and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:

Lot 2A-2 Highlands Ranch #20, 14<sup>th</sup> Amend. 0.940 AM/L.

2. The subject property is classified as Commercial property.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2010:

Land	\$ 286,625
Improvements	\$3,021,108
Total	\$3,307,733

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Land	\$ 286,625
Improvements	\$3,021,108
Total	\$3,307,733

5. After further review and negotiation, the Petitioner and the Douglas County Board of Equalization agree to the following tax year 2010 actual value for the subject property:

Land	\$ 286,625
Improvements	\$2,713,375
Total	\$3,000,000


6. The valuations, as established above, shall be binding only with respect to tax year 2010.
