3. The parties agree that the 2009 and 2010 actual values of the subject property shall be Stipulated Values below:

This information includes actual rent rolls, together with operating income and expense information for the property, which will be provided to the Assessor no later than March 15<sup>th</sup> of each year. *ex*
6. Petitioner(s) agrees to allow access to the improvements for the purposes of measuring or to obtain building condition information during normal business hours. *ex*
7. This valuation is for purposes of settlement only and does not reflect an appraised value. *ex*
8. Petitioner(s) agree(s) to waive the right to a Board of Assessment Appeals hearing and any further appeal of schedule number: 202093 for the assessment years(s) covered by this Stipulation. *ex*
