Petitioner, Farley M. Lozowick, and Respondent Pitkin County Board of County Commissioners hereby enter into this Stipulation regarding the tax year 2010 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this stipulation is described as: Country Club Subdivision, Lot 6, and is identified as Parcel No. 2735 061 01 024 in Pitkin County Assessor's Office records.

2. The County Assessor originally assigned the following actual value on the subject property for the tax year 2010:

3. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:
