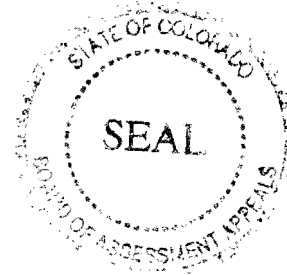

7. Brief narrative as to why the reduction was made:


Further review and correction of various attributes impacting the subject property warranted a reduction in value.
