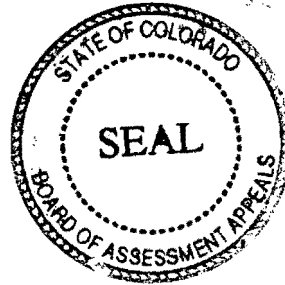

Total	\$	490,000.00


6. Brief narrative as to why the reduction was made:


The stipulated value was agreed upon by Petitioner and Eagle County during pre-hearing discussions.
