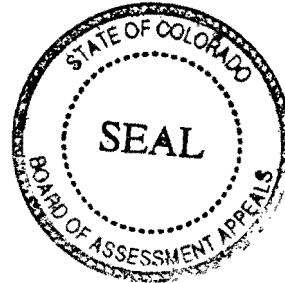

Total	\$ 24,344,000


6. The valuation, as established above, shall be binding only with respect to tax year 2011.
