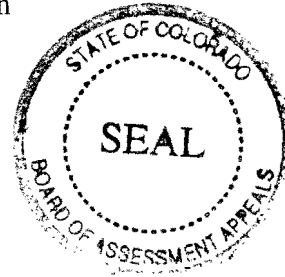

BOTH PARTIES stipulate and agree as follows:

1. The subject property is described as Jefferson County Property Schedule Numbers 431591 and 431592.

3. Note that the stipulated value does not affect the value of the tax exempt portion of the property under Schedule Numbers 431591 and 431592. The parties agree that the 2011 actual values of the subject property shall be Stipulated Values below.

Should an improvement be destroyed, then the Assessor's Office would make a downward adjustment in valuation to reflect the damage to or destruction of that improvement.
5. Petitioner(s) <sup>required pursuant to C.R.S. 39.8.107</sup> agree(s) to provide the Jefferson County Assessor, if applicable, with ~~confidential~~ information to assist in the appraisal process of future years. This information includes actual rent rolls, together with operating income and expense information or the property, ~~which will be provided to the Assessor no later than March 15<sup>th</sup> of each year.~~ (KL)
6. ~~Petitioner(s) agrees to allow access to the improvements for the purposes of measuring or to obtain building condition information during normal business hours.~~ (KL)
7. Petitioner(s) agree(s) to waive the right to a Board of Assessment Appeals hearing and any further appeal of the schedule numbers: 431591 and 431592 for the assessment years covered by this Stipulation. ~~for calendar year 2011.~~ (KL)
