4. The Board concurs with the Stipulation.


**ORDER:**

The Denver County Assessor is directed to change his/her records accordingly.



Petitioner, DENVER LEASED HOUSING ASSOCIATES II LLC AKA ORCHARD CROSSING II LP and Respondent, BOARD OF EQUALIZATION OF THE CITY AND COUNTY OF DENVER, hereby enter into this Stipulation regarding the tax year 2011 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner(s) and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:

2. The subject property is classified as residential real property.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2011.
