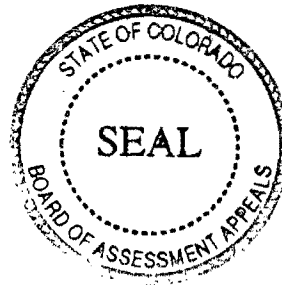

Petitioner, **CHIEF II DENVER HOTEL LLC**, and Respondent, **BOARD OF EQUALIZATION OF THE CITY AND COUNTY OF DENVER**, hereby enters into this Stipulation regarding the tax year 2011 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.
