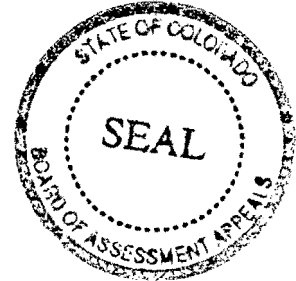

The parties have agreed that the 2011 actual value of the subject property should be reduced as follows:


