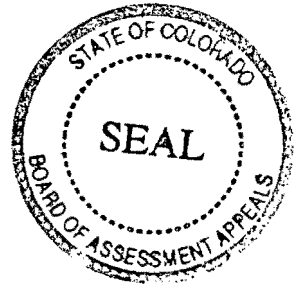

3. The parties agree that the 2011 actual values of the subject property shall be Stipulated Values below:



This information includes actual rent rolls, together with operating income and expense information or the property, which will be provided to the Assessor no later than March 15<sup>th</sup> of each year. 7. Petitioner(s) agree(s) to waive the right to a Board of Assessment Appeals hearing and any further appeal of the schedule numbers: 457295 for the assessment years covered by this Stipulation.
