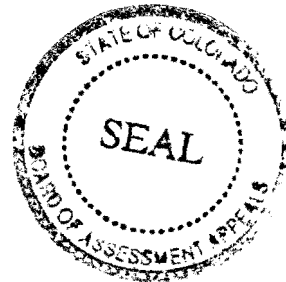

5. After further review and negotiation, Petitioner and County Board of Equalization agree to the following actual value for tax year 2012 for the subject property:



6. The valuation, as established above, shall be binding only with respect to tax year 2012.




