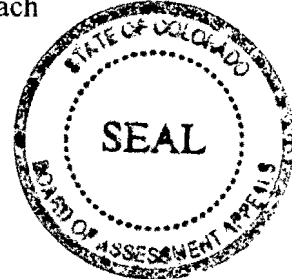

A brief narrative as to why the reduction was made: Applied 2011 value after BAA order.




The valuation, as established above, shall be binding only with respect to the tax year 2012.
