Value agreement arrived at after subsequent analysis of income and comparable sales.


7. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on September 15, 2014 at 8:00 am, be vacated.


8. This Agreement may be executed in any number of counterparts, each of which shall be deemed an original, and all of which shall constitute one and the same agreement.
