Petitioner, PPF AMLI 755 EAST 19<sup>TH</sup> AVENUE and Respondent, DENVER COUNTY BOARD OF EQUALIZATION OF THE CITY AND COUNTY OF DENVER, hereby enter into this Stipulation regarding the 2013 tax year valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner(s) and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:

755 E 19<sup>th</sup> Ave  
Denver, Colorado

2. The subject property is classified as residential real property.

3. The County Assessor originally assigned the following total actual value to the subject property for tax year 2013.

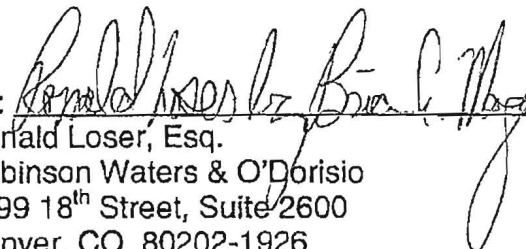
The subject sold within the base period. The subject's value should reflect that sale.

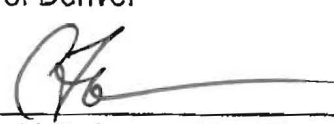
