<b>STIPULATION (As to Tax Year 2014 Actual Value)</b>	

Petitioner and Respondent hereby enter into this Stipulation regarding the tax year 2014 valuation of the subject property and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:  
  
Lots 1 thru 12 Blk 18 Craig & Goulds Addition to Castle Rock together with vacated Front Street & the North 65' of vacated First Street 1.33 AM/L LSP 4097
2. The subject property is classified as Industrial property.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2014:

Land	\$ 405,545
Improvements	<u>\$1,006,105</u>
Total	\$1,411,650

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Land	\$ 405,545
Improvements	<u>\$1,006,105</u>
Total	\$1,411,650

5. After further review and negotiation, the Petitioner and the Douglas County Board of Equalization agree to the following tax year 2014 actual value for the subject property:

Land	\$ 405,545
Improvements	<u>\$ 694,455</u>
Total	\$1,100,000


6. The valuations, as established above, shall be binding only with respect to tax year 2014.

7. Brief narrative as to why the reduction was made:

Further review of account data, market sales, and income/expense data indicated that a reduction in value was warranted.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on January 7, 2015 at 8:30 a.m. be vacated.
