The valuation, as established above, shall be carried forward and applied for tax year 2016 pursuant to C.R.S. §39-1-104 (10.2) unless the Assessor determines that as of January 1, 2016, there is an unusual condition as defined in C.R.S. §39-1-104 (11) that would require a change in said level of value. Taxpayer does not waive the right to contest any determination made by the Assessor with respect to an unusual condition under C.R.S. §39-1-104 that would change said level of value.
- 9. A hearing has been scheduled before the Board of Assessment Appeals for November 18, 2015 at 8:30 a.m. and should be vacated upon the Board's acceptance of this Stipulation Agreement.
