
7. Brief narrative as to why the reduction was made:


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on May 12, 2016 at 8:30 am, be vacated.

9. This Agreement may be executed in any number of counterparts, each of which shall be deemed an original, and all of which shall constitute one and the same agreement.


