8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on, October 21, 2016, at 8:30 am be vacated.


9. This Agreement may be executed in any number of counterparts, each of which shall be deemed an original, and all of which shall constitute one and the same agreement.
