3. The County Assessor originally assigned the following actual value on the subject property for tax year 2013.

4. After appeal to the Denver County Board of County Commissioners, the Denver County Board of County Commissioners of the City and County of Denver valued the subject property as follows:

5. After further review and negotiation, the Petitioner and Denver County Board of County Commissioners of the City and County of Denver agree to the following actual value for the subject property for tax year 2013.

Improvements	\$	<u>84,100.00</u>
Total	\$	2,750,000.00

6. The valuations, as established above, shall be binding only with respect to tax year 2013.

7. Brief narrative as to why the reduction was made:

A review of the income and expenses and occupancy of the subject property indicated a reduction in the value of the subject property.




