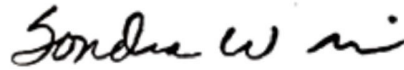

STIPULATION (As To Tax Years 2014-2015 Actual Value)

Petitioner, Duff and Phelps/Kroll LLC representing Braden, Gregory C & Laura A, and Respondent Grand County Board of Equalization hereby enter into this Stipulation regarding the tax years 2014-2015 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this stipulation is described as Subd: STAGECOACH MEADOWS Lot: 57 and is identified as Parcel Number: 1589-114-06-020 in Grand County Assessor's Office records.
2. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property based on the Commercial rate of 29% for tax years 2014-2015.

3. Following the Colorado Supreme Court decision in *Mook v. Bd of Cty Comm'rs* (18SC434); *Bd of Assessment Appeals v. Kelly* (18SC499) and *Bd. of Cty. Comm'rs v. Hogan*


(18SC544), the Petitioner and County Board of Equalization agree to classify the subject property at the Residential rate of 7.96% for tax years 2014-2015, and to adjust the assessed value for tax years 2014-2015.

4. The valuation, as established above, shall be binding with respect to tax years 2014-2015, absent any unusual change in condition to the property.
