4. After appeal to the Denver County Board of County Commissioners of the City and County of Denver, the Denver County Board of County Commissioners of the City and County of Denver valued the subject property for tax year 2015 as follows:

5. After further review and negotiation, the Petitioner and the Denver County Board of Equalization of the City and County of Denver agree to the following actual value for the subject property for tax year 2015.

Improvements	\$	<u>49,201,500.00</u>
Total	\$	51,500,000.00

6. The valuations, as established above, shall be binding only with respect to tax year 2015.

7. Brief narrative as to why the reduction was made:

The value was adjusted after review of actual income and expense levels.


8. Both parties agree to be responsible for their own costs, expert and attorney fees, waiving any claim against each other for such, and agree that any hearing before the Board of Assessment Appeals not be scheduled or be vacated if already scheduled.
