

Petitioner, TLSTX Properties II, LLC, and Respondent Pitkin County Board of Equalization hereby enter into this Stipulation regarding the tax year 2017 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner and Respondent agree and stipulate as follows:

- 1. The property subject to this stipulation is described as Red Mountain Subdivision, Block 3, Lot 1A in Pitkin County records, and is identified as Parcel No. 2737-063-04-001 in Pitkin County Assessor's Office records.
- After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

3. After further review and negotiation, the Petitioner and County Board of Equalization agree to the following tax year 2017 actual value for the subject property:
