4. The Board concurs with the Stipulation.


ORDER:



A brief narrative as to why the reduction was made: Income and sales comparison approaches indicate that adjustment to this value is correct.


The parties have agreed that the 2017/2018 actual value of the subject property shall be reduced as follows:




