Petitioners, Beatrice B Trust, and Respondent Pitkin County Board of Equalization hereby enter into this Stipulation regarding the tax year 2017 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioners and Respondent agree and stipulate as follows:

1. The property subject to this stipulation is described as Woodrun Unit One, Lot 56; and is identified as Parcel Number: 2733 122 01 023 in Pitkin County Assessor's Office records.

2. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows for tax year 2017:

	Total:	\$ 7,650,000

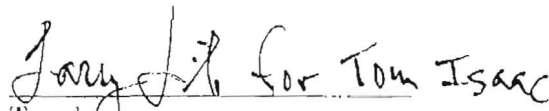
4. The valuation, as established above, shall be binding with respect to tax year 2017 and 2018, absent any unusual change in condition to the property.

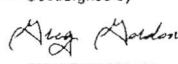
