4. The Board concurs with the Stipulation.

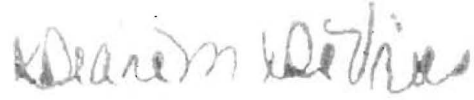
ORDER:

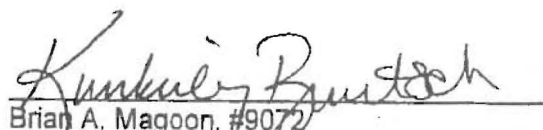
5. After further review and negotiation, the Petitioner(s) and County Board of Equalization agree to the following actual value for tax year 2017.

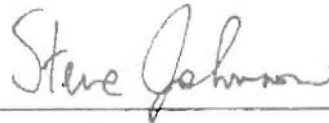
6. The valuations, as established above, shall be binding only with respect to tax year 2017.

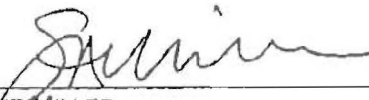
