STIPULATION (As to Tax Year 2017 Actual Value)

Petitioner and Respondent hereby enter into this Stipulation regarding the tax year 2017 valuation of the subject property and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:
Lot 384A Meridian International Business Center 7C, 3rd Amd. 38.167 AM/L.
2. The subject property is classified as Residential Vacant Land property.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2017:
