Total	\$522,000


6. Except as otherwise provided herein, the valuations, as established above, shall be binding only with respect to tax year 2018.

7. Brief narrative as to why the reduction was made:


Physical inspection and new measurements of the portion that is finished indicated that an adjustment to value is warranted.
