**FINDINGS OF FACT AND CONCLUSIONS:**


1. Subject property is described as follows:



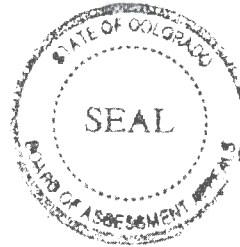


