
4. The Board concurs with the Stipulation.



HC 5. ~~Petitioner(s) agrees to allow access to the improvements for the purposes of measuring or to obtain building condition information during normal business hours.~~

6. This valuation is for purposes of settlement only and does not reflect an appraised value.

7. Petitioner(s) agree(s) to waive the right to any further hearing or appeal of schedule number(s): 300027718 for the assessment years(s) 2018.
