Taxpayer does not waive the right to contest any determination made by the Assessor with respect to an unusual condition under C.R.S. § 39-1-104 that would change said level of value.

9. A hearing has been scheduled before the Board of Assessment Appeals for December 5, 2019 at 8:30AM and the parties request that the hearing be vacated based on the stipulation contained herein.
