4. The Board concurs with the Stipulation.

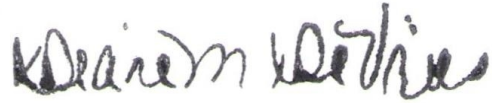
ORDER:



A brief narrative as to why the reduction was made: Revised cost approach indicates that adjustment to this value is correct.






