1. The property subject to this Stipulation is described as:

3. The County Assessor assigned the following actual value to the subject property on the Notice of Determination:

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Land	\$	145,000
Improvements	\$	<u>491,000</u>
Total	\$	636,000

5. After further review and negotiation, the Petitioner(s) and County Board of Equalization agree to the following actual value for tax year 2019.

Land	\$	145,000
Improvements	\$	<u>425,000</u>
Total	\$	570,000


6. The valuations, as established above, shall be binding only with respect to tax year 2019.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on December 4, 2019 be vacated.




