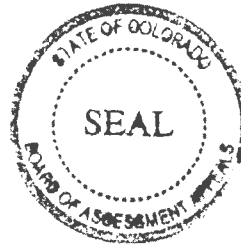

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued schedule 0700767 for tax year 2019 as follows:



5. After further review and negotiation, Petitioners and County Board of Equalization agree to the following tax year 2019 tax value for schedule 0700767:


