Petitioner OXY USA Inc. ("Oxy") and Respondent Mesa County Board of County Commissioners (the "County Board"), by their respective counsel of record, enter into this Stipulation As To Actual Value with respect to the petition for abatement or refund of taxes for tax year 2012 filed by Oxy and partially denied by the County Board.

Oxy and the County Board stipulate that the petition for abatement or refund of taxes is granted in part, and that the actual values assigned to the oil and gas leaseholds and lands for tax year 2012 (before application of the 87.5% assessment ratio) are reduced to the actual values listed on the attached Schedule 1. The total actual value assigned to all of the oil and gas leaseholds and lands for tax year 2012 (before application of the 87.5% assessment ratio) is

reduced to \$64,670,990, which results in an assessed value of \$56,587,810. The reduction in actual value was made based on additional information and analysis.

The parties further stipulate that the entry by this Board of an Order accepting this Stipulation As To Actual Value will result in a refund payment to Oxy in the amount of \$150,000. Such refund payment will be made by the Mesa County Treasurer no later than December 31, 2020.

The actual values set forth in this Stipulation As To Actual Value and on Schedule 1 shall be binding only with respect to tax year 2012.

The parties jointly request that the Board enter an Order accepting this Stipulation As To Actual Value.
