The Petitioner and Respondent agree and stipulate as follows:

Adjustment to the account was merited based upon adjustments to a cost multiplier and depreciation calculation for the improvements, allocation of some of the land/site improvement value for parking that is shared by the attached medical office buildings but do not have parking within their accounts, and a reduction in land value based on the campus' size when compared to the sales utilized to establish land value in the neighborhood (LEA).

8. Because 2020 is an intervening year, the parties have further agreed that the 2020 value shall also be adjusted in order to make it consistent with the 2019 value.

9. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on June 23, 2020 at 8:30 a.m. be vacated.
