<p>STIPULATION (As to Tax Year 2019 Actual Value)</p>	

Petitioner and Respondent hereby enter into this Stipulation regarding the tax year 2019 valuation of the subject property and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:

Lot 3A Mark Six Business Subdivision 1st AMD 1.83 AM/L
2. The subject property is classified as Industrial property.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2019:

Land	\$ 398,574
Improvements	<u>\$2,536,226</u>
Total	\$2,934,800

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Land	\$ 398,574
Improvements	<u>\$2,536,226</u>
Total	\$2,934,800

5. After further review and negotiation, the Petitioner and the Douglas County Board of Equalization agree to the following tax year 2019 actual value for the subject property:

Improvements	<u>\$2,451,426</u>
Total	\$2,850,000


6. Except as otherwise provided herein, the valuations, as established above, shall be binding only with respect to tax year 2019.


7. Brief narrative as to why the reduction was made:

During the study period the building was occupied by a single tenant and via the income approach did not reach the rental potential, thus indicating a reduction in value was warranted.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on July 31, 2020 at 8:30 a.m. be vacated.
