STIPULATION (As to Tax Year 2019 Actual Value)	

Petitioner and Respondent hereby enter into this Stipulation regarding the tax year 2019 valuation of the subject property and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:

Lot 13H-1 Park Meadows Filing 2 Amendment 12 Total Acreage 1.50 AM/L
2. The subject property is classified as Commercial property.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2019:

Land	\$ 784,080
Improvements	<u>\$ 849,780</u>
Total	\$1,633,860

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Land	\$ 784,080
Improvements	<u>\$ 849,780</u>
Total	\$1,633,860

5. After further review and negotiation, the Petitioner and the Douglas County Board of Equalization agree to the following tax year 2019 actual value for the subject property:

Land	\$ 784,080
Improvements	<u>\$ 699,920</u>
Total	\$1,484,000

6. Except as otherwise provided herein, the valuations, as established above, shall be binding only with respect to tax year 2019.


7. Brief narrative as to why the reduction was made:

For the BAA analysis, the income approach revealed that the model rental rent was too high for a larger single user which resulted in an adjustment to value.


8. Because 2020 is an intervening year, the parties have further agreed that the 2020 value shall also be adjusted in order to make it consistent with the 2019 value.

9. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on July 14, 2020 at 8:30 a.m. be vacated.
