STIPULATION (As to Tax Year 2019 Actual Value)	

Petitioner and Respondent hereby enter into this Stipulation regarding the tax year 2019 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is located at:
1585 W. 115th Avenue, Westminster, Colorado.
2. The subject property is classified as Residential property.
3. The County Assessor originally assigned the following actual value to the subject property for tax year 2019:

Land	\$ 2,976,712
Improvements	<u>\$28,864,460</u>
Total	\$31,841,172

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Land	\$ 2,976,712
Improvements	<u>\$23,583,286</u>
Total	\$26,559,998

5. After further review and negotiation, Petitioner and County Board of Equalization agree to the following actual value for tax year 2019 for the subject property:


Land	\$ 2,976,712
Improvements	<u>\$17,727,086</u>
Total	\$20,703,798

6. Both parties stipulate and agree that the valuation as established above is binding with respect to tax year 2019 and that further adjustment, whether brought under legal or factual grounds, shall be precluded.


7. Brief narrative as to why the reduction was made: A closer look at the market sales and the estimated time trend indicates that the property was previously overvalued. The property is a restricted income property and qualifies for an economically derived market adjustment (EDMA). The adjustment was applied to the market value.
