4. The Board concurs with the Stipulation.


**ORDER:**

The Denver County Assessor is directed to change his/her records accordingly.

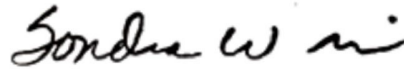
