**STIPULATION (As to Abatement/Refund for Tax Year 2019)**

Petitioner and Respondent hereby enter into this Stipulation regarding the tax year 2019 valuation of the subject property and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:  
Lot 17 Blk 5 Perry Park East 1 5.00 AM/L
2. The subject property is classified as Residential property.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2019:

Land	\$284,105
Improvements	<u>\$404,406</u>
Total	\$688,511

4. After a timely appeal to the Board of Commissioners, the Board of Commissioners valued the subject property as follows:

Land	\$284,105
Improvements	<u>\$404,406</u>
Total	\$688,511

5. After further review and negotiation, the Petitioner and the Douglas County Board of Commissioners agree to the following tax year 2019 actual value for the subject property:

Land	\$284,105
Improvements	<u>\$350,895</u>
Total	\$635,000

6. Except as otherwise provided herein, the valuations, as established above, shall be binding only with respect to tax year 2019.


7. Brief narrative as to why the reduction was made:


Further review of property characteristics and expanded search for comparable sales indicated that a change in value was warranted.

8. Because 2020 is an intervening year, the parties have further agreed that the 2020 value shall also be adjusted in order to make it consistent with the 2019 value.

9. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on April 1, 2021 at 8:30 a.m. be vacated.
